The Data Request Task Team and Thematic Author Groups welcome any feedback Modelling Centres, MIPs and the wider community can provide on the current Data Request content.

The form asks a few high-level questions to help inform the Data Request harmonisation work.

Modelling Centres

MIPs and other activities

In addition to the high-level questions, we have also asked you to indicate your alignment to Opportunities and your interest for variable groups. This will help modelling centres prioritise the Opportunities and make sure they support your MIP. You will see in the CMIP7 Data Request v1.0, MIP responses are listed alongside the Opportunities.

Opportunity feedback: In the Opportunities questions, you can indicate whether whether an Opportunity will produce science which is essential for your MIP/activity. We would expect only a few Opportunities to be High priority per MIP/activity. You can also flag if the science produced by an Opportunity would be relevant for your MIP/activity, but is not essential for your science goals by selecting 'Low priority'. Science goal alignment should be limited to AR7 Fast Track timelines.

Variable group feedback: In the Variables group questions, you can indicate your support for variable groups. In the first phase on consultation, Variable Group proposers indicated if they thoughts a variable group would be of interest to a MIP. We now ask you to either 1) offer to take ownership of a Variable Group or 2) express interest for a Variable Group. If you offer to take ownership, this implies that future questions and/or changes to the Variable Group will be done in consultation with someone from your MIP/activity. You do not need to be the original proposer to offer ownership of the Variable Group.

Please provide consolidated responses from your MIP or activity. This form will not save if you leave the webpage. If you have previously provided responses to the questions below, either from the v1.0beta release spreadsheets, or by previously completing the form, we will assume your new answers supersede your previous answers.
